



Hamilton County Seniors No-Cost Legal Help with Benefit Eligibility

Are you a Hamilton County senior struggling to afford food, healthcare or prescription medication? Pro Seniors can help!

Many seniors don't realize that they are eligible for one or more government benefits programs that help pay for food, healthcare and prescriptions.

These programs include: Supplemental Nutrition Assistance Program, Community Medicaid, Medicare Premium Assistance Program, and Medicare Extra Help.

Eligibility

Hamilton County seniors meeting the following criteria qualify for no-cost legal assistance from Pro Seniors for this project:

- 1. 60 years of age or older,
- 2. Household income at or below 80% of Area Median Income (AMI),

Many attorneys on our Helpline Referral Panel accept reduced fee and pro bono matters.
